#### 1) NETC Website Refresh

- Josh Casey, CTC's Web Designer, took the group through the development website.
- Home page News items will go here. The home page has a flexible area that we can figure how best to use.
  - Emily Use the flexible spaces for latest projects, newly selected projects in the spring and most recently completed projects.
- Sidebar We can choose which pages have sidebars and the content for each of them.
- Interior pages Content for some of them taken from the current site.
- On the current site, the active and completed research projects are on separate pages. On the new site, Josh put them on one page with a sort function to allow the visitor to search for what they want. This makes it easier to navigate.
  - ~ Projects are filterable by project category and status. We can add a project completion date field.
  - ~ Any field in a project sidebar could be added as a filter on the page.
  - ~ A search box is also available.
  - There is an option to have a separate page that displays all the active research projects. It would be a page that only has one filter of active research projects.
- Project pages They have their own type of sidebars with project information. The categories won't appear on the page if they are empty.
  - ~ names will be on each project page.
- Josh implemented a file management system. Once a file is added and categorized, it will show up in the correct places on the site.
- Visitors will be able to sign up for the NETC emails.
- Member login area We need to figure out what will go there.
  - Project information Parts of pages could be password protected. The content wouldn't be visible on the project page (or any other page) unless you are logged in.
    - o Brian Can you indicate that there is members-only content on that page? Josh Yes.

- Emily The AC should decide what wouldn't be public. She wants all TC meeting
  information available to everyone. Action item: Kirsten will organize this discussion.
- Dale Once the website is live, can we put a count on the pages to see which pages are visited the most? Some websites have so much content and can cross the line into a document management website. Josh Analytics will be available.
- Brian Josh leveraged some of work CTC has done for other pooled fund websites, so you might see similar options on those sites.
- Next steps Get comments from AC in the next week. Josh will make changes based on the
  feedback. Maina and Kirsten will also review the individual pages to update them prior to the
  site going live. The site should be able to go live in the next month or so, barring any major
  issues.
- Action item: Kirsten will send everyone the link to the development site and ask for feedback.

    GoToMeeting webinar from CTC. Action item: Colin will notify Kirsten when this is needed.

  - Ann Will the webinars be recorded? Lily Yes. Two have taken place and the recordings are available.
- Colin NCHRP solicitation closing in early November. Any NETC problem statements that we want to put forward? Action item: Kirsten will send list to the AC. Sent on 9/22/20.
  - ~ The next NETC solicitation begins in December.
